V. EDUCATIONAL SERVICES

5.1 Student Enrollment – Dr. Bridges reported enrollment Year-to-Date has increased almost 200 students. Expect increased enrollment due to Tracy Hills phase #2 having sold 200/400 homes and we anticipate 100 to 125 new students. Commute parents are an uncertainty since they may leave their students enrolled where they work.

5.2 2024-2025 Mid-Year LCAP Update

Scott Andrews presented the LCAP Goals to the Board. Mr. Andrews went over the 14 goals and the accomplishments for each.

Student Chronic Absences was discussed as the district implements a new Pilot Grant with the County Office to allow school districts to bill Medi-Cal and Insurance providers directly. In order to do that a Doctor, Nurse, Speech Pathologist, Occupational Therapist, Social Worker/PPS Credential, Psychologist, allows district to bill Medi-Cal or provider for reimbursement. We are trying to ensure that whoever provides services to student, can actually bill in finalizing the job description.

Food Services was highlighted as a new vendor was selected to introduce diverse menu choices, fresh fruit options and ease of ordering. We will not cook raw meats at this time. An on-site chef will train our staff. The goal is thee (3) items every day; protein and vegetarian items. Trying to push diverse menu to push palettes. These are Nationwide Vendors that source from local vendors.
