#### Welcome and Introductions:

Review of LCAP plan: See Draft LCAP Plan.

We reviewed the LCAP Goals and Actions and Services for the 2021 LCAP Draft. This will go to the Board in June for approval.

# Review EL Plan:

The District will revise our LCAP Federal Addendum to be Board approved in June for the required Title III Plan. (LEAs are allowed to use a Local Plan or the LCAP Add. Document but it must be board approved by June 30<sup>th</sup> with Conap)

GLAD Certification Training – Suggested was made to send a personal invitation to the staff who are not yet certified so that they take advantage of the summer learning opportunity.

We do not have a revised district EL Plan to review at this time. The ELPAC online test training, preparation, and administration were all very time consuming this school year. We did not want to take additional time away from EL support services at the sites so we did not meet as a team to review and update the District EL Plan. This will be a high priority project next school year.

#### Review Criteria for Reclassification:

Some students will not have CAASPP score data. We will look to use DIBELs scores and the 2021 ELPAC Summative score data to determine Reclassification early Fall, next school year.

To be considered for reclassification, students must meet the following requirements:

- 1. Demonstrate English Language proficiency with an overall score of 4 on the ELPAC.
- 2. Demonstrate academic proficiency by earning a 3 or 4 on the ELA CAASPP Summative Assessment or earn "above benchmark" score on DIBELS Assessment.
- 3. Demonstrate academic proficiency in classroom work, by achieving a grade of "C" or better in Reading and Language Arts.

4. Teacher and Principal recommendation. Parent opinion and consultation.

Schedule DELAC meeting dates for 21-22:

October 14, 2021 and May 12, 2022 (TBD - Zoom and/or In-Person)

Additional meetings will be scheduled for EL Aides/Paras to include ELPAC training and Plan revision time.

# Other -

Imagine Learning: Sarah Steen met with the reps and reviewed site usage this school year. Students who consistently logged in showed great performance and progress in the assessment. We do plan to continue the subscriptions next school year for Language and Literacy as well as their reading program. They suggested we create a contest to encourage students to access the online resources during the summer break. Our district license will reset on August 9, 2021. Coach asked if chromebooks can be checked out over the summer if students do not have a device at home to participate in Imagine Learning at home this summer.
